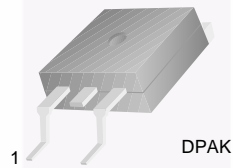

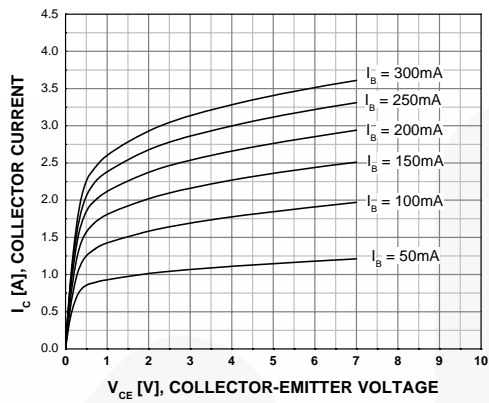


Figure 1. Static Characteristic

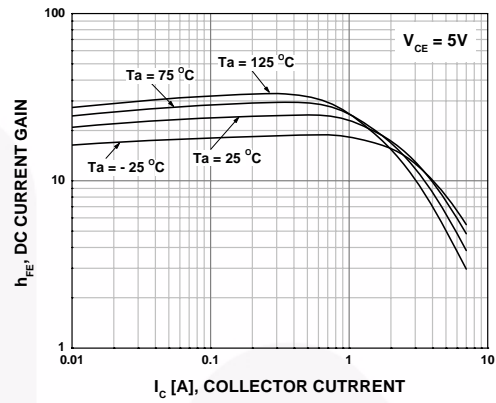


Figure 2. DC Current Gain

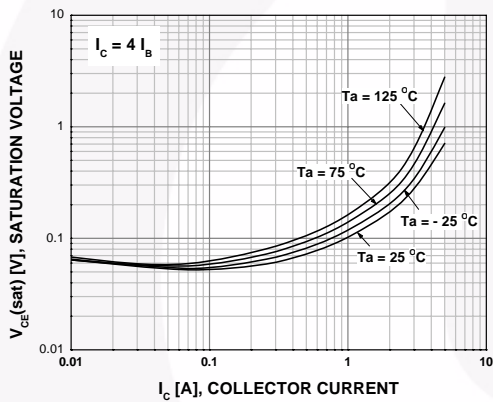


Figure 3. Collector- Emitter Saturation Voltage

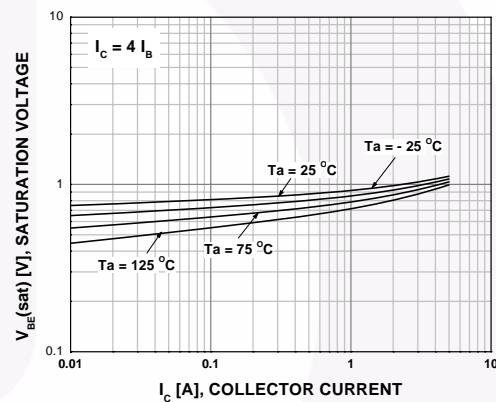


Figure 4. Base - Emitter Saturation Voltage

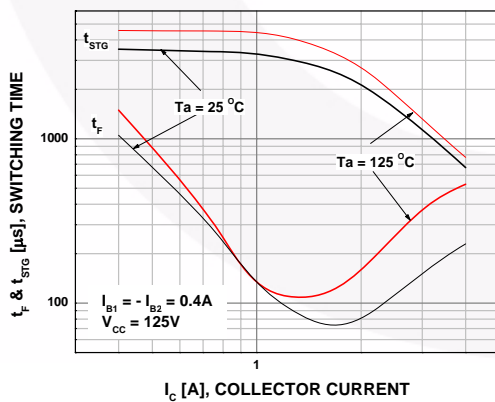


Figure 5. Switching Time

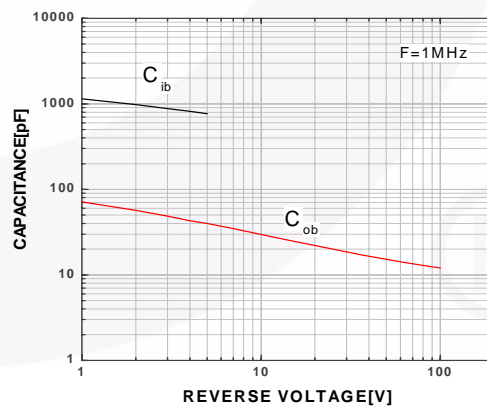


Figure 6. Capacitance

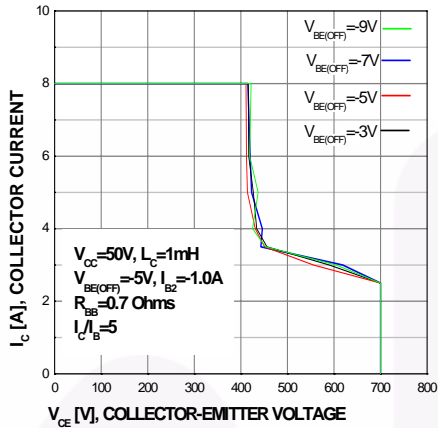


Figure 7. Reverse Biased Safe Operating Area

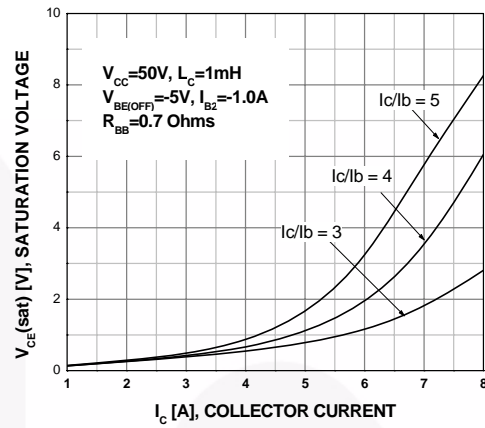


Figure 8. Collector- Emitter Saturation Voltage at RBSOA

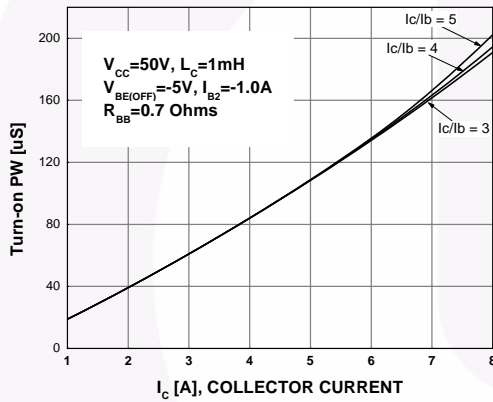


Figure 9. Input Pulse width vs Correct current at RBSOA

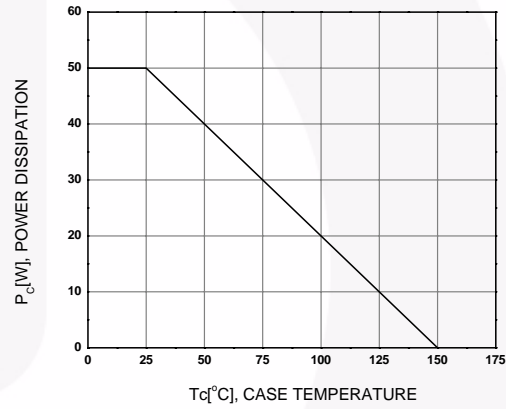


Figure 10. Power Derating

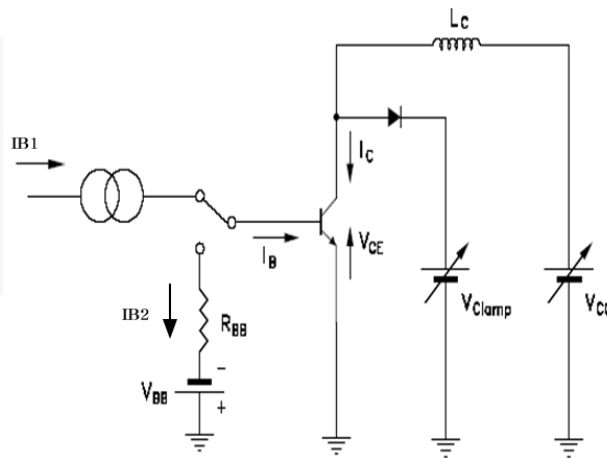
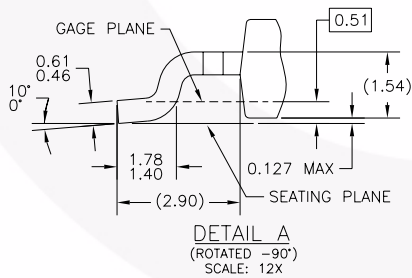
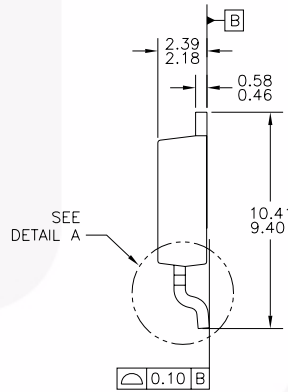
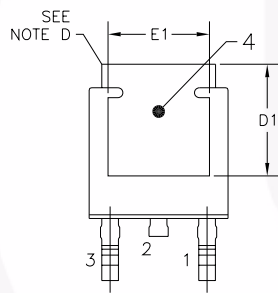
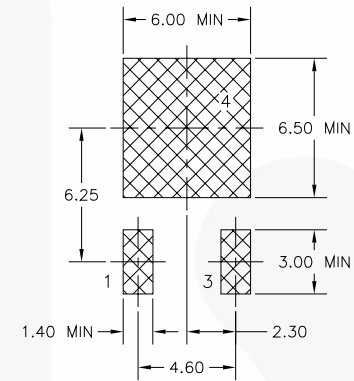
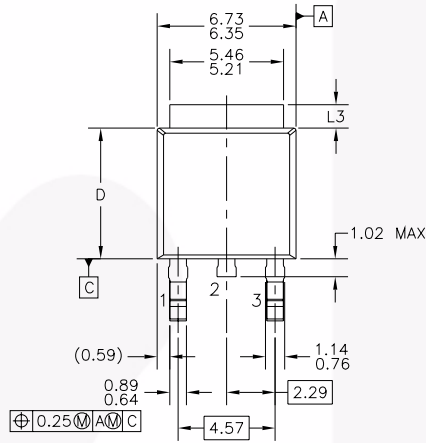


Figure 11. RBSOA Test Circuit
