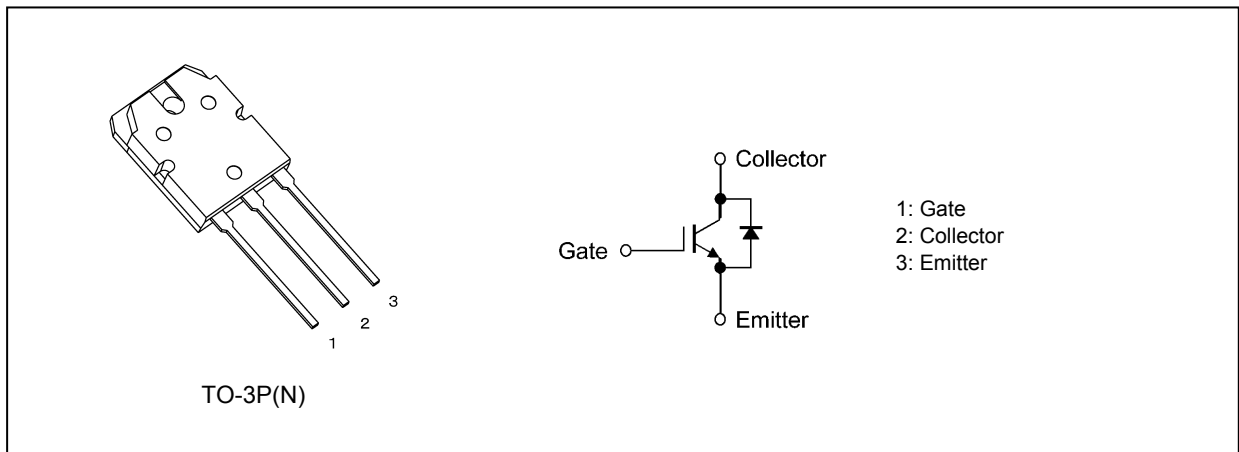

Therefore, please design heat release of a device with due consideration to the temperature rise of IGBT.

Note 1: Ensure that the junction temperature does not exceed 175 $^{\circ}\text{C}$.

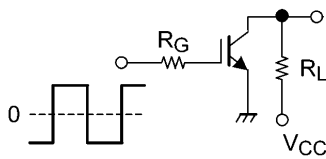


Fig. 6.2.1 Test Circuit of Switching Time

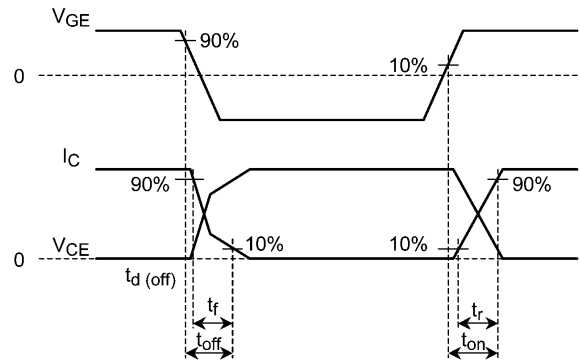


Fig. 6.2.2 Timing Chart of Switching Time

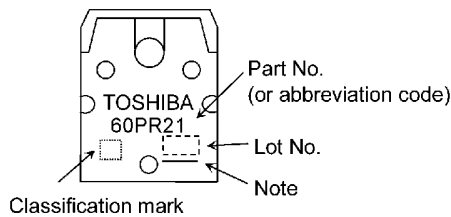


Fig. 7.1 Marking

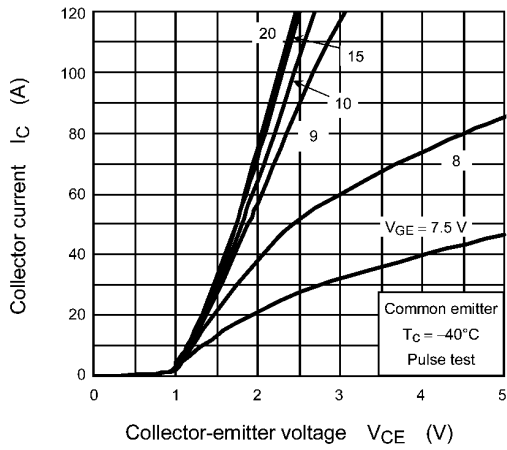


Fig. 8.1 $I_C - V_{CE}$

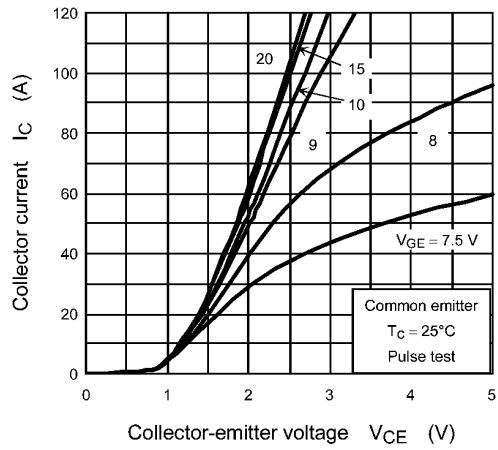


Fig. 8.2 $I_C - V_{CE}$

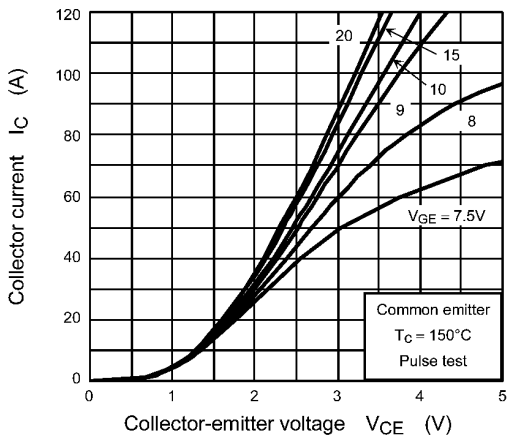


Fig. 8.3 $I_C - V_{CE}$

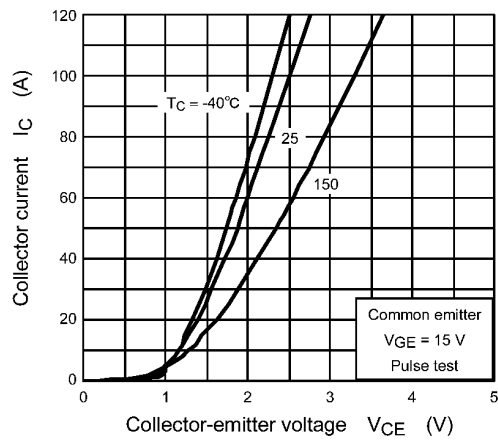


Fig. 8.4 $I_C - V_{CE}$

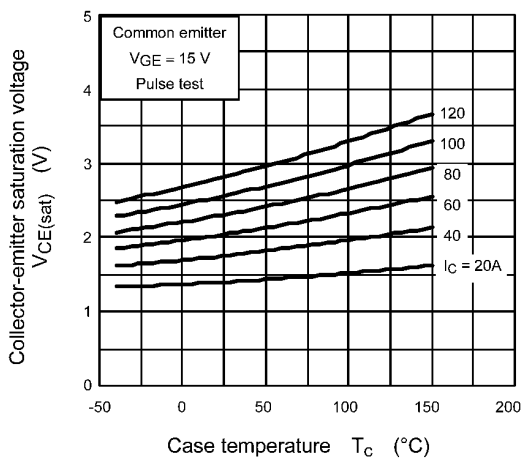


Fig. 8.5 $V_{CE(sat)} - T_C$

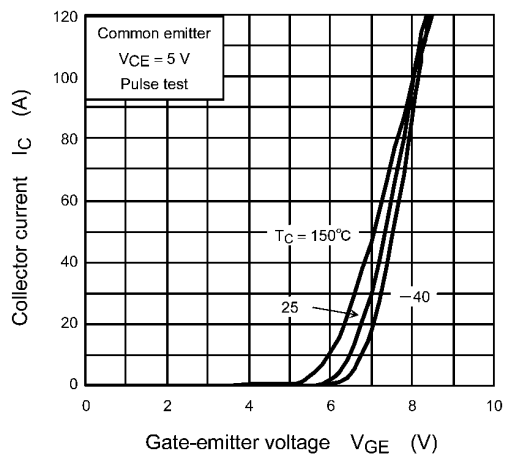


Fig. 8.6 $I_C - V_{GE}$

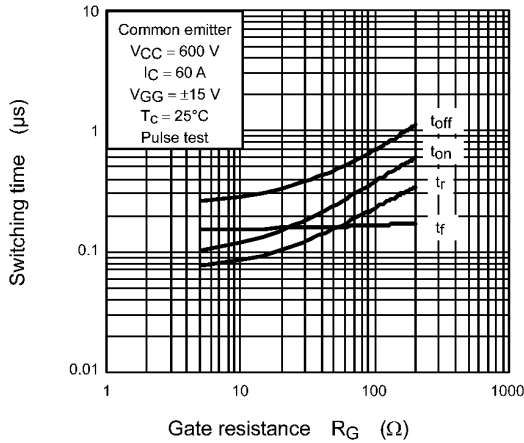


Fig. 8.7 Switching Time - R_G

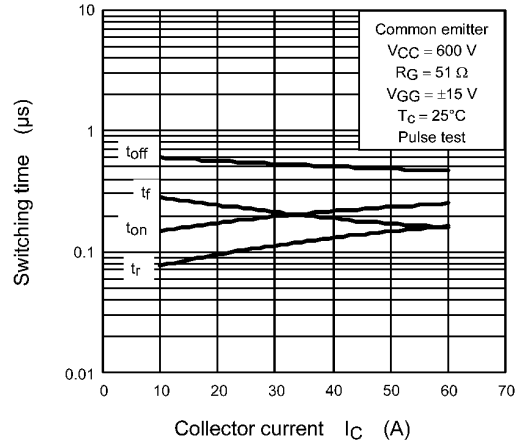


Fig. 8.8 Switching Time - I_C

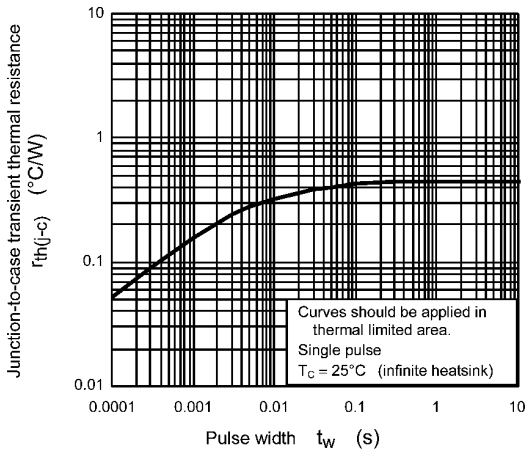


Fig. 8.9 $r_{th(j-c)} - t_w$ (Guaranteed Maximum)

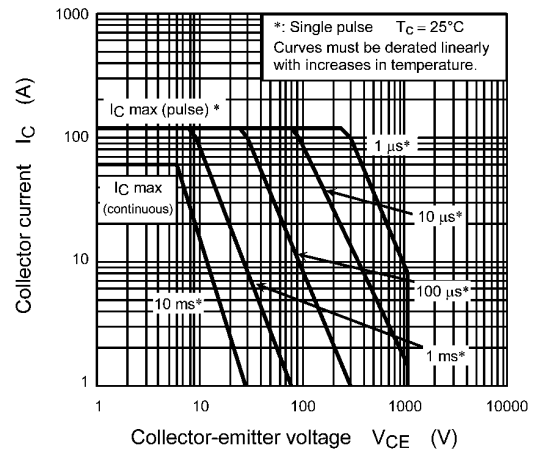


Fig. 8.10 Safe Operating Area (Guaranteed Maximum)

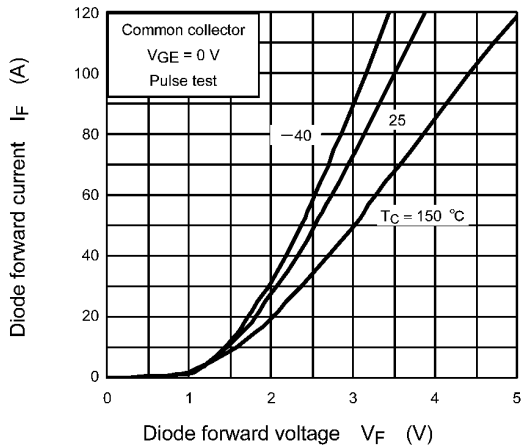


Fig. 8.11 $I_F - V_F$
