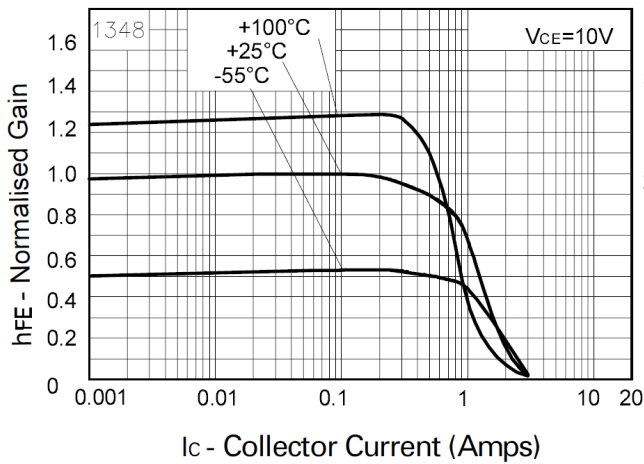

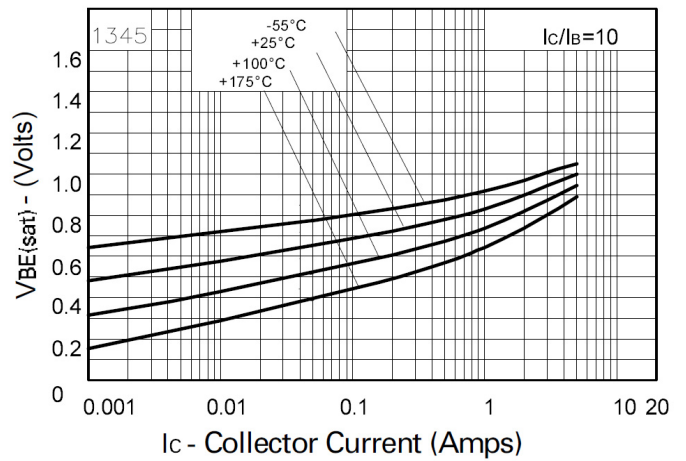
VCE(sat) v IC



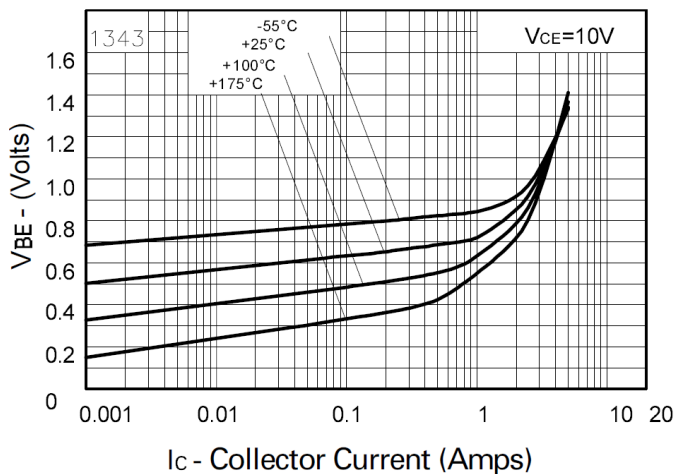
VCE(sat) v IC



hFE v IC



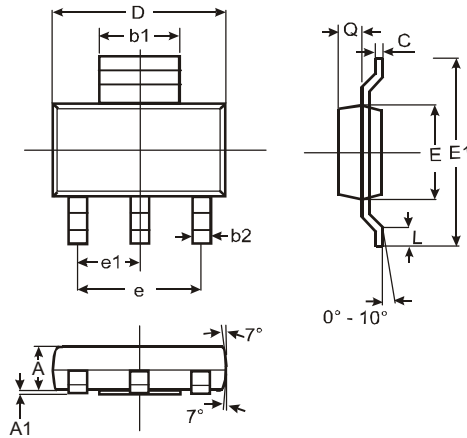

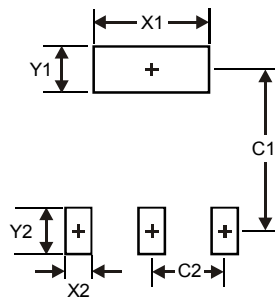
